WSOS and Hancock County ADAMHS Board Dedicate New Homes



On June 20th the Wyandot, Seneca, Ottawa and Sandusky Community Action Commission (WSOS) in conjunction with the Hancock County ADAMHS Board dedicated two new homes. These homes are located at 147 & 148 Lotze Street in Findlay. Each home has two bedrooms and bathrooms a shared kitchen and living area.

WSOS took the lead on the project as a recipient of a Federal Neighborhood Stabilization Grant. The grant required that property locations needed to be abandoned homes in high foreclosure areas. The units were built with energy efficient utilities and are furnished with a washer and dryer, central air and heat and furnishing as needed by tenants.

Groups involved in the project include WSOS, Habitat for Humanity, ReMax Realty, Lancia Homes and Century Health.

The ADAMHS Board also took time to honor an individual who has helped create harmony throughout the community. These homes were dedicated as "Dysinger Lots" in honor of Barbara Dysinger. Barbara was the first school counselor for Findlay City Schools, serves on the Findlay City School Board and is a past member of the Hancock County ADAMHS Board and Century Health Board. The dedication plaque that will be hung at one of the homes reads "The homes of 147 and 148 Lotze St. are named in honor of Barbara Dysinger in recognition of her caring approach to promoting harmony between individuals, families

Carolyn Copus to Chair ADAMHS Board


Carolyn Copus

respective leadership roles and bid a fond farewell to Larry. A thank you is also extended to Tom Buis for his outstanding service as Board Chair.

Also at the June Board meeting, FY '13 contracts were awarded. The two largest contracts awarded were to Century Health for \$1,718,030 and Family Resource Center for \$592,000. Total expenditures for FY '13 are \$3,868,615.

My name is Tiffany. I am a felon, a mental health patient and a recovering addict. I am 25 years old and have been homeless three times in four years. Alcohol is my toughest monkey (if you will) to set free. In 2009, that monkey cost me a lot! I let parties and friends run my life. That resulted in me being robbed of my "nest egg" and my rent money. I also spent a week in jail on a probation violation.

When released from a week-long stay in jail for a probation violation, I was homeless and lived in my van for the second time that year. My best friend had just moved into Basu Point and allowed me to stay with her for a few days. I stayed in her apartment, her mother's house and my van. After three or four months the resident manager of Basu Point told me about an available apartment and how to apply to be a resident.

In January of 2010, I had four months of sobriety under my belt; mainly because I did not have a fridge in my van and I knew there would be random room checks. Having a permanent address to give to the Probation Office meant that there would be more curfew checks.

Finally, I had somewhere to call my home. It felt great. My depression started to get better and my confidence was slowly building back up. I've now been sober for roughly three years and have a job that I went to school for and love. I can't say I owe it all to living at Basu Point, but I know I owe my current sobriety to residing here.

To me, Basu Point isn't just a place "where crazy people live" as I have heard multiple people describe it. It is a place where people like me can get the hand up we need, not the hand out most people think we want. Some of my neighbors struggle with their past demons, just like most of society. Some of them need the extra help they get by living here. Either way, without Basu Point, I think some of us would just be lost, wandering around in an over-judgmental society.

The Hancock County ADAMHS Board/ Community Partnership would like to say goodbye to Paul Kreidler and Keith DuVernay.


Paul has been a friend to services for children


